


Fig.1 'Control of externally provided processes, products and services' Process Model

'Control of externally provided processes, products and services' Process model is displayed on Fig. 1.

The 'Control of externally provided processes, products and services' process includes three sub-processes:

- 1) Purchasing Management ensuring delivery of products (equipment, raw materials, components, etc.) and services to be included in the Organization's own products and services (section 4.2).
- 2) Outsourcing management interaction with external providers who <u>carry out</u> the <u>process</u> or part of the process <u>for the Organization</u> (section 4.3).
- 3) Supply Chain Management on behalf of the Organization, including franchising the interaction with external providers, that <u>supply products</u> and services directly to the customer(s) <u>on behalf of the Organization</u> (section 4.4).
